- **A non-refundable deposit of \$125** must accompany this form; the deposit is deducted from the total dues. Notice of withdrawal of remaining monies must be in writing and sent certified mail to above address by *May 15, 2020*. No refunds after *May 15, 2020*. Any membership not paid in full by *May 15, 2020* may be subject to availability. No bonds to be sold after *June 1st, 2020*.
- Member families may also **enroll ONE babysitter** for additional **fee of \$175**. Babysitter must be 14 years of age as of *January 1, 2020*. Do not include the babysitter when calculating family size.
- **Bond payments** are due no later than *June 1, 2020*.
